Centre fees

Centre Approval

This fee applies to centres who are not currently approved by KPA. It covers the full cost of the approval process including the review of your application and an EQA visit.

The first 50% of the approval fee is to be paid when submitting your application with the remaining balance to be paid once you receive the outcome of your application. Please note: 100% of the fee is payable regardless of the outcome of the approval.

Ongoing Centre Recognition and Monitoring

This fee applies to all KPA approved centres. This fee will be applicable one year from your initial agreement and covers annual monitoring visits and delivery support from KPA.

KPA will inform you of the type of ongoing fee which will be applicable before you sign any Centre Agreement or Service Level Agreement.

Annual Centre Recognition Fee (for centres delivering open market qualifications)	£1,050
Annual Centre Monitoring Fee (for customers who are delivering a bespoke qualification)	£1,575
Additional support or monitoring visit (remote)	£578
Additional support or monitoring visit (on-site)	£578 plus expenses

Qualification Development and Accreditation Fees

The fees in this section apply to any centres or customers who want to work with us to accredit or regulate a new or existing bespoke qualification. These fees cover all activities within the qualification development process.

Centre approval fees will apply if you are not already a KPA approved centre.

Reference to a new qualification means any qualification which does not have a fully developed qualification specification.

Reference to an existing qualification means any qualification which has a fully developed qualification specification.

Qualification Regulation Fee (For an existing qualification to be accredited and regulated)	£1050 per qualification
Qualification Design and Accreditation Fee (For a new qualification to be designed and accredited but not regulated)	£3675 per qualification
Qualification Design and Regulation Fee (For a new qualification to be designed, accredited and regulated)	£4725 per qualification

Appeals Fees

Stage 1 - Initial Review	£58
Stage 2 - Independent Review	£58 plus any additional expenses that may be incurred during the independent review in seeking the opinion of professional experts

These charges will be refunded in full if the appeal is upheld.
